## FAQs

### Overview

Working with children and their families in the Children's Disability Network Team will enable you to support their development, wellbeing, and participation in family and community life, as well as bringing together groups of children and their parents to learn new skills and share experiences.

The Children's Disability Network follows a Family Centred Practice approach, which involves getting to know the children and their families, finding out their goals, building an individual support plan, and helping them use everyday activities to achieve their goals.

Services are provided by HSE and through funded partnership with organisations including voluntary organisations (Section 38 & Section 39), known as Lead agencies. Websites are available for each of these lead agencies and can be accessed through

## Working in a Childrens Disability Network Team

Is previous work experience with children required?

With regard to HSE posts within CDNTs specific eligibility criteria for posts are available at <https://www.hse.ie/eng/staff/jobs/eligibility-criteria/>

Eligibility is outlined for each post and the various grades under those posts, for example the different requirements to be eligible for a senior post as opposed to a staff grade post.

What qualifications are required for working in a CDNT?

The National Framework of Qualifications (NFQ) describes what learners need to know, understand and be able to do to achieve a qualification. It lists the main qualifications awarded at each level and pathways from one NFQ level to the next.

## International Recruitment

Is recruitment undertaken outside Ireland & how can overseas workers join the CDNTs?

In many cases an individual will be required to 'be registered or entitled to be registered'.

Therefore individuals can apply for jobs without registration once they are eligible, however an individual can only be appointed to a post once they are registered.

## **Other**

### **Provide links to section 38 and 39 CDNT websites**

The HSE provides and funds a range of services for people with disabilities and their carers. These services include basic health services as well as assessment, rehabilitation, income maintenance, community care and residential care respite, home care and day care.

Some services are provided directly by the HSE. Community, residential and rehabilitative training services are provided by voluntary organisations with grant aid from the HSE.

### **Are flexible working hours available?**

The hours are advertised with the Job. However there are many statutory and non-statutory working arrangements within disability services, for example people have a statutory right to parental leave and the disability service also have non-statutory leave which staff can apply for such as Shorter Working Year leave. Generally the disability services tries to support their staff in achieving a work life balance while still providing the services required by children and their families. If you are interested in working in a CDNT register your interest at career hub and apply for jobs which come up. If you are offered a job or offered a job you can talk about your preferred work pattern with the manager.

### **Are there challenges in working in a CDNT?**

Many staff, including those who presented at the July 2024 webinar and within the videos, describe their work within a CDNT as a fulfilling and rewarding job Demand for services does exceed our current capacity which is challenging for children and their families along with the staff. Building up the number and skillset of staff within Childrens disabilities services is a priority for the Irish government and for the Irish health services. The increase in staff and the development of the skillset working within disability services is complemented by work in other areas. This work includes improving our communication with Children with disabilities and their families and building resources for those children and their families to use while they are waiting for services and engaged in their Individual Family Support Plan (IFSP).
